Medicinal Agricultural Product Scheme

The Central Agricultural Development Institution has a provision of providing credit to farmers in all the regions of India, by providing them credit facilities, such as = 10,000 per acre of credit, and to provide them training of medicinal agricultural plants free of cost, for which the Institution has been identified / registered. Ensuring availability of high quality fertilizers / seeds / others to farmers that has been produced by farmers medicinal agricultural products (Raw Material) selling produce materials not less than half price fixed by the government of india to support the farmers or will provide them one and a half time more price than the money they spend on their farm . The system of direct transfer is a provision under the zero corruption based policy.

The following facts/reports came to light in view of corruption in physical /other forms of share of agriculture / farmers: Bank loan problem is often the root factor of farmer suicides. The basic reason for rural migration is the lack of accessible agriculture/other system at the village level. Continuous shortage of employment (national/state level) in the departmental/agricultural sector despite the immense possibilities of employment (government jobs and rural employment). Livestock system which may be physically involved in the allied arrangements of agriculture, not to be included in actual or non-compliance of policies. There is no laxity in the rules against corruption for the general public but for the government officials to relax the rules. If caught taking a bribe, then taking a bribe, taking an exemption etc. was seen in the system (government system). Often the agency of physical supervision of the actual implementation of the schemes released by the Central/State Government, etc., was not seen to work on the actual ground. The lack of physical verification of the actual implementation of schemes/projects/policies/mandates/others issued by the Central/State Government was reflected.

OBJECTIVES OF INSTITUTION

1. This scheme could be directly availed by agriculturists/farmers, by first tracing or locating the potential beneficiaries, then training them through different modes free of cost.
3. The Scheme incorporates the facility of “Krishak Sewa Kendra or Mini Collection Center or Milk Collection Center” wherein the edible yield or the raw agri product/produce with one district one product scheme (i.e. Milk, Rice, Paddy, Wheat, Pulses, Oil Seeds and other seeds, vegetables etc.)

presented by the farmer member for sale fetches at least the minimum aid Price but not less than Minimum Selling Price (MSP) declared by Government of India.

4. The farm yield purchase will be facilitated via formation of “Krishak Sewa Kendra or Mini Collection Center or Milk Collection Center” at “Nyaya/Gram Sabha” level, under which yield will be paid off to the indebted/other farmer member registered with institution in their respective bank accounts and the financial institution (FI)/Bank concerned within 12 to 32 hours through NEFT/RTGS/Other banking channels in the ratio of 2:3 or 3:2 i.e. or a part of the produce price will be paid directly to the FI(Financial Institution)/Bank and the other portion to be paid off to the farmer member directly in the specified rate of share of 60%: 40% or vice versa, per the above ratio via DEDS (Dairy Entrepreneurship Development Scheme)/other milk based program or schemes/grade schemes/maps or others. This facility will be ensured on all agricultural and allied sector related raw and other produce.

5. To provide technical development or artificial intelligence to the Krishak Sewa Kendra/Mini Collection Center/milk collection center by installation of CCTV Cameras, this will be connected to Headquarter for online monitoring purpose.

6. To provide Milk Chilling Plant/Warehouse/Plant/Flour Processing Unit/Cold Storage and/or others Agri and allied sector product processing Mini/Micro/high Processing Unit at District/Zone or Region/state or international/national or national/state or state/zone/region or region/zone/district level units and others jointly having capacity of daily processing milk of 1.80 lacs ltr to 20 lacs litres or 1.80 lacs mt. to 20 lacs m.t. capacity and mega food park.
